§ 134.01 PUBLIC INDECENCY

No person shall, while in or in view of a public place, perform:

(A) An act of sexual intercourse

(B) An act of deviate sexual intercourse;

(C) An act of exposing his or her genitals with the intent of arousing the sexual desire of him or herself or another person; or

(D) An Act of urination or defecation except in toilets provided for that purpose.

§ 134.02 CURFEW

(A) No minor shall be in or upon any street, highway, park, alley, or other public place between the hours of 10:00 p.m. and 6:00 a.m. of the following morning unless:

(1) Such minor is accompanied by a parent, guardian or other person 18 years of age or over and authorized by the parent or by law to have care and custody of the minor;

(2) Such minor is then engaged in a lawful pursuit or activity which requires the presence of the minor in such public places during the hours specified in this section; or

(3) The minor is emancipated pursuant to O.R.S. 419B.550 to 419B.558.

(B) No parent, guardian or person having the care and custody of a minor under the age of 18 years shall allow such minor to be in or upon street, highway, park, alley, or other public place between the hours specified in division (A) of this section, except otherwise provided in that division.

(C) Any minor who violates division (A) of this section may be taken into custody as provided in O.R.S. 419C.080, 419C.085, and 419C.088 and may be subjected to further proceedings as provided by law.

§ 134.03 POISONING ANIMALS

No person shall put out or place any poison with the intent to poison any horse, cattle, sheep, hog, dog, or domestic animal.

§ 134.04 REMOVAL OF CARCASSES

No person shall permit an animal carcass owner or controlled by him or her to remain upon public property, or to be exposed on private property, for a period time longer than is reasonably necessary to remove or dispose of the carcass.

§ 134.99 PENALTY

(A) General. Any person who shall violate any provision of this chapter for which no other penalty is provided shall, upon conviction, be subject to penalties as set forth in § 130.99 of this code.

(B) Curfew. Any minor violating the provisions of § 134.02(A) of this code shall be dealt with in accordance with juvenile court law and procedure. Any parent, guardian, or other adult person having the care and custody of a minor violating § 134.02(B) of this code shall be fined not less than \$5 nor more than \$500 for each offense.
