CHAPTER 75: PARKING SCHEDULES

Schedule

Section 1 Parking restricted zones

Section 2 Truck Parking; prohibited locations

SECTION 1: PARKING RESTRICED ZONES.

(A) *No Parking*. The parking of any vehicle on the streets designated below is hereby forbidden, and the curb of the sidewalk for that distance shall be painted, indicating there is to be no parking vehicles next to the painted curb.

No Parking Zones			
Street	Side	Location	
Front Street	North	Where the Post Office is located, for a distance of 30 feet west from the intersection line of the street with the near line of Washington Street.	

(B) Angle parking and double parking prohibited. It shall be unlawful to park any motor vehicle other than parallel to the curb or to double park on the streets as designated below.

Parking Method Restrictions					
Street	Location	Prohibited Parking Method			
Front Street	Between Jefferson Street and Madison Street	Parking other than parallel to the curb, or double parking.			

- (C) Section 3 of Ordinance 263 is amended to read as follows:
- 1.) No person shall operate any motor truck upon any public street or alley within the city unless such street or alley has been designated as a truck route under this ordinance.
- 2.) Motor trucks being operated on the public street not designated on the truck route, are exempt from the restriction of this section if they are being operated for the specific purpose of:

- a. Discharging or picking up goods at any business or residence.
- b. Going to or from a business or residence for the purpose of repairs, or for the purpose of parking on private property or upon a public street as allowed by ordinances of the City of Merrill.
- c. Servicing utility facilities or construction sites.
- d. Emergency Vehicles.
- e. City or City franchise vehicles.

SECTION 2: TRUCK PARKING; PROHIBITED LOCATIONS.

Section 4 of Ordinance 263, as amended by Ordinance 331, is amended to read as follows:

1.) No truck parking shall be allowed on the following streets and or locations in the City of Merrill:

Front Street	North	a. The North side of Front Street, from the sign posted across from the intersection of East Court Drive, extending East to intersection of Monroe Street.		
Front Street	North	b. The North Side of Front Street from the alleyway intersection east of Monroe Street, to the intersection of Clay Street.		
Front Street	North	c. The North side of Front Street, from the intersection of the alleyway between Clay Street and Lincoln Street, extending east to the intersection of Elm Street.		
Front Street	South	d. The South side of Front Street, from the sign posted across from the intersection of Polk Street, and extending east to the sign posted across from the intersection of the alleyway between Madison Street and Clay Streets.		
Front Street	South	e. The South of Front Street, from the sign posted across from the intersection of Clay Street, and extending East to the intersection of Elm Street.		
Main Street	West	f. The West side of Main Street, from the North side of the Fire Hall, South to the intersection of Main Street of the Lost River Bridge.		
Merrill Road	West	g. The West side of Merrill Road, from the intersection of Front Street to the North side of the Lost River Bridge.		
Merrill Road	East	h. The East side of Merrill Road, from the intersection of Front Street, South to the North side of the Lost River Bridge.		
Roosevelt, Elm & Willow Streets	Any	i. Any location on Roosevelt Street, Elm Street, or Willow Street.

Front Street	North	a. The North Side of Front Street, from the intersection of Monroe Street to the intersection of the alleyway east of Monroe Street		
Front Street	North	b. The North Side of Front Street, from Clay Street East to the intersection of the alleyway between Clay Street and Lincoln Street.		
Front Street	South	c. From the sign on the south side of Front Street, 75 feet east to the sign across from the intersection of Polk Street.		
Front Street	South	d. The Southside of Front Street, East from the sign across from the alleyway between Madison Street and Clay Street, to the sign across form the intersection of Clay Street and Front Street.

Parking Schedules

Section 3: Section 7 of Ordinance 263 is amended to read as follows:

Restrictions:

- (1) a. The truck operator shall use the most direct route available to move and from the destination location to an established truck route.
 - b. Vans or trailers shall not remain stationary for more than one week.
- c. No Truck or truck trailer shall be parked closer than twenty feet to any intersection. (Ord. 250, passed 3-5-1985; Am. Ord. 263 passed 8-8-2006) Penalty see, § 70.99 **Cross-reference:**
