# MEETING CALLED TO ORDER:

Mayor Pro Tem Johnson called the Wednesday, January 11, 2023 Business Meeting to order at 5:30 p.m.

#### ROLL CALL:

Roll call was taken with the following members of Council and others being present: Mayor Pro Tem Johnson, Councilor Gatliff, Councilor Baley, Councilor McCollam (*arrived 5:36 p.m.*), and City Recorder Hernandez.

## FLAG SALUTE:

The Flag Salute immediately followed with Mayor Pro Tem Johnson requesting Councilor Gatliff take the lead.

### MAYOR STATEMENT:

Mayor Pro Tem Johnson asked that everyone please turn cell phones on silence. All meetings are recorded. When addressing the City Council, please speak clearly and state your name.

Mayor Pro-Tem Johnson stated the public is invited to provide their comments and opinions to the City Council at this time on issues of concern. ## STAFF REPORTS:

# Police:

Report: Police Commissioner Baley stated the City of Malin Police Department continues to issue traffic tickets, which has included semi-trucks, several arrests that include warrants (one in Merrill), and three welfare checks. Police Commissioner Baley stated a retired employee retrieved personal belongings from the office without personal knowledge and stated displeasure. Police Commissioner Baley discussed the open position for Chief of Police with Sheriff Kaber. Police Commissioner Baley stated contacting Oregon League of Cities to post the open position; however, Oregon League of Cities never followed through with an email. City Recorder Hernandez stated the position has already been posted with the Oregon League of Cities.

#### Public Works:

• Public Works Director Matthews submitted report and read: Checked lifts; well level is 74 foot with pump running; completed and submitted Discharge Monitoring Report; hung pink tags; performed six locates; allowed outside dumping, which has resulted in approximately \$65,000.00; cleaned restrooms; fixed two sewer plugs; wrote article for newsletter; fixed water main break at Clay Street; attended Work Session December 19, 2022; pumped off Water Street Lift Station and Billy Gallagher fixed electronics; pumped off Willow Street Lift Station; City Engineer Darryl Anderson released Swisher Road and Fourth Street Water Project Bid for publishing; PPL lost a leg on transformer and burned a heat sensor at lagoon, which required a \$350.00 replacement the Winema Electric repaired; Utility Worker Taylor and Roman Vazquez have been remodeling City Hall; plowed snow; replaced front tire on snowplow; repaired radiator on side-by-side; Rodney

Green repaired carburetor on flusher truck; mailed Road Report to Oregon Department of Transportation; mailed Road and Bridge Report to Oregon Department of Transportation; attempted to resolve dispute regarding private sewer line running under neighbor's property, which is a civil matter; assisted potential business create plan for sewer connection; communications involving manufactured home replacement, which has been rescinded.

### City Recorder:

City Recorder Hernandez reported: completed Employee W-2's, filed NEC 1099 and 1096, filed I-Wire Reconciliation, filed 1099 and W-2 with the Oregon Department of Revenue and Social Security Administration, uploaded Northwest Retirement Employee Data Schedule and Questionnaire, created and posted Chief of Police Advertisement, Business Oregon correspondence, created Resolutions, and other administrative duties.

#### Lawyer:

 Report: City Recorder Hernandez requested the Lawyer Audit Letter be emailed to Robin Peile at Romig & Peile.

#### Planning:

Report: The Planning Commission had a pre-application meeting regarding a Land Use Compatibility Statement for 228 W Front Street. The plans include a food truck and trailer that will provide restrooms. The owners are attempting to locate the sewer line with the assistance of Public Works Director Matthews. Lighting was discussed. Parking will not be allowed on the lot and the business will have all customers park on the street. City Engineer Darryl Anderson has requested the applicants include bench seating and landscaping to the Land Use Compatibility Statement. City Clerk Northcutt stated Oregon Department of Transportation has agendized the application for January 23, 2023, as the property is along HWY 39.

# LOST RIVER ARTS AND CULTURAL ALLIANCE:

Public Works Director Matthews reported the Merrill Historical Society, Klamath County Museum, and Lava Beds National Monument is holding a seminar Tuesday, January 17, 2023 located at 301 E Second Street Merrill, Oregon 97633 at 6:30 p.m. The Klamath County Museum has advertised the event. The Merrill Historical and Modoc War Museum houses an astonishing photography collection from the Modoc War, which will be displayed. Another Modoc Tour will be held Saturday, January 14, 2023 starting at the Merrill Historical and Modoc War Museum. The Lost River Bluegrass festival signed the final band. The line-up will be the Edgar Loudermilk Band from Georgia, the Western Flyers from Texas, the Central Valley Boys from California, Kentucky Sky from Idaho, Walter Jamboree from Tennessee, and local Mountain Valley Stranglers. Lost River Arts and Cultural Alliance held a board meeting January 10, 2023 to discuss business that included festival pricing. The prices for tickets and camping will remain the same, The mission is for the festival to remain affordable for families. Discussions of funding and sponsorships ensued. Bev Moore, owner of Farm Country Nursery, estimated the Merrill Beautification flower baskets will cost \$2,800.00 or more. Public Works Director Matthews requested \$3,000.00 from the Solar Fund to fund the flower baskets. Councilor McCollam made a motion to approve \$3,000.00 to Lost River Arts and Cultural Alliance for the flower baskets. Councilor Gatliff 2<sup>nd</sup> the motion. The motion passed 4-0 in favor. Lost River High School Senior Jesli Hernandez has completed her Senior Project and is on her way to graduating!

#### **NEW BUSINESS:**

Discuss Schedule for Meetings with County Commissioners: Klamath County Commissioners are
requesting a semi-annual meeting with respective Council/leaders for updates in projects within the
community. The first meeting would be in March at the Government Center located at 305 Main Street in
Klamath Falls. The second would be at the September 13, 2023 City Council meeting. The consensus of the
City Council was to schedule a meeting no later than March 15, 2023 later in the afternoon.

- Oregon Department of Transportation Speed Zone Investigation Report: The City of Merrill submitted a Speed Study Application in 2020. Oregon Department of Transportation is recommending reducing the speed T Les Schwab Tires and the Dollar General from 45 to 30; reducing city limit speed from 30 to 25; and reducing the speed at St. Augustine's Church from 45 to 30. Oregon Department of Transportation is seeking City Council approval to the recommendations. Councilor Gatliff made a motion to approve the Speed Zone recommendations. Councilor McCollam 2<sup>nd</sup> the motion. The motion passed 4-0 in favor.
- Oregon Liquor and Cannabis Commission Update Advisory to Cities and Counties: Applications must be approved with the city or county before proceeding to the State of Oregon.
- Appoint Budget Committee (Teresa Perry, Ben Keeney, Miles Gatliff, Franceska McAuliffe): Councilor Gatliff recused self, due to conflict of interest. Councilor McCollam made a motion to appoint the Budget Committee. Councilor Baley 2<sup>nd</sup> the motion. The motion passed 3-0 in favor with one recusal due to conflict of interest.
- Approve Letter to Horizon PWR: City Council read the letter contained within City Council packet prior to the meeting. City Council authorized Mayor Pro Tem Johnson to sign the letter.
- Letters of Interest for Mayoral Vacancy/Appointment: No letters of interest have been submitted.
- Discuss Employee Pay Schedule Revision: During the December 19, 2022 Work Session, the consensus was to eliminate Step O, add federal cost of living to each Step, and revise the verbiage to: Steps 1-7 shall be annual in addition to federal cost of living. Steps 8-10 shall be bi-annual in addition to federal cost of living. After an employee has reached Step 10, the employee may qualify for a longevity raise. All raises are subject to the City of Merrill's fund availability; therefore, the City of Merrill reserves the right to suspend raises due to budgetary constraints. Councilor Gatliff inquired whether the Officer Pay Schedule included cost of living increase to each Step. City Recorder affirmed and would make necessary changes to reflect included cost of living. Councilor Gatliff made a motion to approve the Pay Schedule changes. Councilor Baley 2<sup>nd</sup> the motion. The motion passed 4-0 in favor.
- Discuss Part-Time Code Enforcement Officer: City Recorder Hernandez stated the City of Merrill is hiring for a Chief of Police/ Marshal that job duties shall include Code Enforcement; however, the City of Merrill is unsure when the position will be filled. There is an interest in the Code Enforcement part-time position by a local resident that would benefit the City greatly. Wages were approved for a Code Enforcement Officer for the 22-23 Fiscal Year Budget and to hire a Code Enforcement Officer is possible. Councilor Gatliff stated approval to proceed with a Code Enforcement Officer. Councilor McCollam approved with a review of the Code Enforcement position when the Marshal is hired. The transfer of job duties could be distributed to the Marshal, City Clerk Northcutt, and Code Enforcement Commissioner. Code Enforcement Commissioner Baley stated having time for Code Enforcement in the winter with no violations. In the spring, Code Enforcement Commissioner Baley is called away from work for Code Enforcement complaints; therefore, the only option is to proceed since self cannot perform the duties of Code Enforcement nor City Clerk Northcutt, and the City does not have a Marshal. City Clerk Northcutt opined that a Code Enforcement Officer year-round is essential so there is a person available to have abatements completed in a timely manner. Public Works Director Matthews praised the perspective Code Enforcement Officer, Details regarding the appointment of a Code Enforcement Officer ensued, Councilor McCollam made a motion to open the Code Enforcement Position to appointment. Councilor Gatliff 2<sup>nd</sup> the motion. The motion passed 4-0 in favor.
- Discuss Chief of Police Advertisement: City Recorder Hernandez created an advertisement based upon feedback from the December 19, 2022 Work Session. Upon completion, the City Councilors were phone polled for approval to post to meet City Council's deadline. City Recorder Hernandez listed the publishing sites: Herald & News, Klamathbasinjobs.com, Oregon State Police/DPSST website, League of Oregon Cities, Oregon Chiefs of Police Association, City of Merrill website, Indeed, Zip Recruiter, Jobs2Careers, Nexxt, Glassdoors, and niche sites. The City of Merrill received a resume within 24 hours of the posting. City Recorder inquired to iHireLawEnforcement posting for \$349.00. City Council declined.
- Renew Police Contract with Malin Police Department: The Malin City Council approved the police contract at the January 10, 2023 City Council Meeting. Councilor Gatliff made a motion to approve the renewed police contract. Councilor Baley 2<sup>nd</sup> the motion. The motion passed 4-0 in favor.

- Resolution 2023-910 LUC Extension Request: City Recorder Hernandez read Resolution 2023-910 LUC Extension Request into the record. Councilor Gatliff made a motion to approve Resolution 2023-910 LUC Extension Request. Councilor McCollam 2<sup>nd</sup> the motion. The motion passed 4-0 in favor.
- Resolution 2023-911 Transfer Funds to Comply with Budget Law and Increase Line Item: City Recorder Hernandez read Resolution 2023-911 Transfer Funds to Comply with Budget Law and Increase Line Item into the record. Councilor McCollam made a motion to approve Resolution 2023-911 Transfer Funds to Comply with Budget Law and Increase Line Item. Councilor Baley 2<sup>nd</sup> the motion. The motion passed 4-0 in favor.
