Merrill Elementary was recently awarded Safe Routes to School Planning assistance from the Oregon Department of Transportation (ODOT). Through this program, Klamath County School District and ODOT are working together to create a Safe Routes to School (SRTS) Plan that identifies street improvements near Merrill Elementary to support students and families in walking and rolling to school safely. The SRTS Plan will also recommend opportunities for education and engagement to promote walking and rolling to school. Planners from Alta Planning + Design, an active transportation consulting firm, is guiding the planning process.

This spring, the project team has been collaborating remotely to identify and prioritize safety needs within a mile of the school. The team will host a socially-distant walk audit to observe student arrival and dismissal. The team and community members will also document the walking and biking conditions around the school area.

This summer, the team will identify SRTS construction, education, and engagement recommendations and complete the SRTS Plan.
